Congratulations!

Each year an officer of the Toastmasters International Board of Directors visits select Districts in conjunction with the District's annual conference. Toastmasters International would like for an International Officer to visit your District during the 2024 District conference season.

Please provide the dates and location of your conference as soon as possible.

Once we have the dates of your conference, we will be able to share which International Officer will be visiting. World Headquarters will then send additional information and materials to help you plan the visit and schedule time with your District team (District Director, Program Quality Manager, Club Growth Director, Public Relations Manager, and anyone else involved in the planning of the visit) and the visiting International Officer on a conference call.

As a part of this District visit, it is expected that the visiting Officer receive time for an unopposed Keynote speech that is 20-60 minutes in length and an unopposed education session. Your District should leverage the Officer visit to market Toastmasters to local corporations and groups. Your District should arrange three or more events, such as appointments, summits, or open houses, etc. This includes corporations, universities, government agencies, associations, nonprofit organizations, and communities. Your District should also promote the attendance of your visitor, complying with the brand manual and using the visitors official photo (which you can find on the Toastmasters website.)

All District visits are subject to change based on need, and the schedule of the visiting officer. This can also depend on the amount of work the District has been able to generate for the visiting officer, for example, if the officer is not provided a keynote and education sessions, it can result in a cancellation of the visit.

Please confirm receipt of the email with your understanding and confirm the dates and location of your conferences.
