will allow the two highest placed available contestants,

in each area, in each speech contest,

to proceed to the division contest.

This clause is perpetual communication of the rule in the Speech Contest Rulebook.

Change 3.4 to "(deleted)"

Motion 5

"That we condense DP 7.3 and DP 7.4, into a single Procedure."

Reason

Both sections relate to the role of the District Parliamentarian, it is unnecessary to have them as 2 procedures

Action

Renumber paragraph 7.3 as 7.3.1 and 7.4 as 7.3.2 Change 7.4 to "(deleted)"

Motion 6

"That we move DP 8.7, to a new section 8.1.1"

Reason
